### Hybrid Business Classes in Portland During Winter Term

Do you plan to live in the Portland area during Winter Term, but want to continue taking *in person* Business classes? If so, OSU College of Business is offering 3 hybrid courses at our new downtown Portland center located in historic Pioneer Square:

- **BA 312** - Third-Year PERSONAL, PROFESSIONAL, LEADERSHIP DEVELOPMENT (1 credit)
- **BA 352** - MANAGING INDIVIDUAL & TEAM PERFORMANCE (4 credits)
- **BA 381** - PERSONAL & PROFESSIONAL DEVELOPMENT (4 credits)

**Because these are hybrid courses (a combination of in-person and online instruction), students are required to attend class in person once a week in Portland. If you are unable to meet this mandatory attendance requirement you should not register for any of the 3 courses.**

#### Advising Appointments

**Walk-in appointments** will be available from Nov. 7 through Nov. 29. Walk-in appointments are 10 minutes, and primarily deal with urgent registration issues.

**Regular advising appointments** are also available to schedule for 30-minute time slots.

### Attention International Undergraduate Students:

Remember, to maintain your F-1 or J-1 visa you must be full-time each term by taking at least 12 credits total and 9 credits must be on campus.

### Determining which Finance and Marketing course to take:

**BA 240 FINANCE:** is limited to COB majors who will be second-year standing after Fall Term.

**BA 360 INTRO to FINANCIAL MANAGEMENT:** is limited to COB majors and minors who will be third- or fourth-year standing after Fall Term.

**BA 223 PRINCIPLES OF MARKETING:** is limited to COB majors who will be second-year standing after Fall Term.

**BA 390 MARKETING:** is limited to COB majors and minors who will be third- or fourth-year standing after Fall Term.

### Registration

Registration for Winter Term opens **Nov. 11**. We encourage you to schedule an advising appointment to discuss classes for winter term.

### PINs

**Common COB PIN: 262746**

**Continuing students:** Most continuing students won't be asked to enter a PIN to register for winter term classes. If asked, try the **Common PIN** above.

**Student athletes, Post-Bacc, and DAS students:** You need a new PIN - contact your advisor for your new PIN, and we recommend that you schedule an appointment to discuss next term classes.

**Students using veteran benefits:** You need a new PIN - you will receive an email from Head Advisor Carol Leder with your PIN and important registration information.

**First-year students:** You are **REQUIRED** to meet with an advisor to get your winter term PIN. To ensure you get an appointment prior to your registration time please call to schedule your appointment soon.

**Is this your first term at OSU?:** If so, you need a new PIN to register for next term's classes. Schedule an advising appointment to discuss classes and to get the new PIN.

### GPA requirement for Graduation

To graduate from the College of Business you must have a **College of Business GPA of a 2.5 or higher**. The College of Business GPA is calculated using OSU grades only from all classes required to complete your College of Business degree program.
